### **RULES and REGULATIONS**

1. Contestant must be four or five years old on September 1, 2020.
2. At least one of the contestant's parent/guardian must be a resident of Harrison County, Indiana.
3. The Little Miss will receive a tiara and Little Master will receive a crown. Both will receive a trophy and a gift basket full of a variety of prizes.
4. Runners-up will receive a trophy and a small gift basket.
5. All non-placing contestants will receive a gift bag.
6. The 2020 Little Miss and Master are asked to return to crown the 2021 Little Miss and Master.
7. Contestants may only win once; if the child wins when 4-years-old, they may not compete when 5 yrs. old.

### **INTERVIEW**

When: Saturday, September 19, 2020 at 1:30 pm

Where: Harrison County Fairgrounds at the Talmage Windell Ag Building

Typically we have a party for the children to play at and be interviewed by the judges. Due to social distancing and the CDC guidelines, we have decided to forego a party for the 2020 year. Instead, contestants will interview with the judges one-on-one. While waiting, contestants will color at a table, socially distanced from the other children. One parent or guardian is asked to stay with their child while waiting for their interview time.

For the interview, contestants may wear what they please. Sunday best, their favorite dress up outfit, etc. (Please no swimwear or anything showing the child's midriff.)

Masks are recommended, however not required.
